The rules, regulations and the structure of the departments should be such so as to enable the administration to function automatically with speed and efficiency. At each level, responsibilities should be fixed and adequate powers and resources allocated so that these may function with ease and speed.

गांधी जी 1892 से 1914 तक दक्षिण अफ्रीका में थे । उन्होंने वहाँ अफ्रीकी तथा भारतीय लोगों के साथ यूरोपवासियों का अमानवीय व्यवहार देखा । जब वे भारत लौटे तो उन्होंने अपने अनुभवों का तथ्यात्मक विवरण प्रकाशित किया । किंतु इस विवरण को इंग्लैंड और दक्षिणी अफ्रीका में अतिशयोक्तिपूर्ण रूप में अत्यधिक प्रसारित किया गया और इससे दक्षिण अफ्रीका के गोरे लोग गांधी जी से नाराज हो गए । जब गांधी जी डरबन वापस आए तो उनके विरुद्ध जन-भावना फैल गई । नेटाल सरकार ने कुछ दिनों के लिए उनके जहाज को बंदरगाह में घुसने से रोक दिया और उनको उससे उतरने से रोकने का प्रयास किया ।
