At that time, none of the fourteen peaks above 8000 metre were climbed, even though several attempts were made. There were neither maps nor any clues of possible ascent to there peaks Mourice and Louis Lachenal reached the summit of Annapurna on 3 June 1950 but underwent 16 operations later and could never climb again.
